It sets “N” as a variable value. “N” = domestic box office return × 65% + cost of production × 35%.</p> <p>The films are categorized into five classes according to the amount of “N”. Each class has its own royalty rate and each class has a “basic fee” and “annual fee”.</p> <p>For those films whose “N” value are less than RMB10 million, and for those films that have not been shown in the cinema, the license fee will be RMB 5,000-50,000 per year per website.</p>
